Help Required:

As you are aware, we try and introduce the honeybee in as informative a way as possible to the General Public. One way we do this is by attending local shows throughout the summer.

At the moment it is difficult to be definite about dates or shows for year but a separate note will be sent out when dates are confirmed

We need as many members as possible to indicate their willingness to help at our 'information stands' – an enjoyable time, no experience necessary.

Those volunteering will be contacted in good time as to exact dates and their availability.

IMPORTANT NOTES

- Membership will cease if a subscription is not paid by February 28th. Further, for a payment made after this date there is a 40-day delay before B.D.Insurance becomes effective, and there will be a £10 re-joining charge.
- All colonies must be insured. Where, at the time of inspection, by a duly authorised Bee Inspector, the number of colonies managed exceeds the number for which a premium has been paid, no cover will apply for any hive under the policy. When determining the number of colonies to insure, potential increase must be taken into consideration. NOTE: A colony is any hive regardless of size. A nucleus, a swarm, an Apidea mating box each is classed as a colony.
- Third Party Insurance does not cover vandalism or theft. Cover for these items are available though BBKA (at extra cost) and details are available from the Secretary of BBKA.
- The Association officers are not legal or insurance experts, and any statement, whilst made in good faith, may not be legally binding.
- 5 **Membership classes**:

<u>Registered Member</u>, replaces the previous 'Full member' category. Where more than one beekeeper resides at the same address, one person must be a 'Registered Member'.

<u>Partner Member</u> – a category where other beekeepers reside at the same address as a 'Registered Member'. A 'Partner Member' is cover by the BBKA insurance. Only one set of BBKA & ADBKA official literature/correspondence will be distributed to that address.

<u>Associate Member</u> (who must be a member of a Beekeeping Association affiliated to the BBKA) will not receive official literature from BBKA etc through the ADBKA. The Association, of which they are a registered member, will supply this.

Honorary Member Must pay for bee disease insurance if keeping more than three hives.

<u>Junior Member</u> – member under 16 years of age at the start of the subscription year, parent or guardian must be a registered member

The Association uses a computer to hold your name and address. The members details will only be used for Association business and communication with and between members, and the BBKA database. Where members have signed to agree, your details will be passed to the appropriate authority for the Swarm list and Regional Bee Inspector list.
